The GlideScope[®] GVL size 2 Stat is used in conjunction with the GlideScope[®] Video Baton 1-2 as part of the GlideScope[®] Single Use system which is intended for use by qualified medical professionals to obtain a clear, unobscured view of the vocal cords for medical procedures.

Reason for the Voluntary Correction:

Verathon Inc. has become aware that product labelled as GVL[®] size 2 Stat lot GC32825 was physically packaged with GVL[®] size 1 Stats. As a result, patients for intubation with a GVL[®] size 2 Stat may inadvertently be intubated with a smaller GVL[®] size 1 Stat.

Risk to Health:

The identified risk to health is remote. There have been no reported patient incidents associated with the mislabeling of this lot, worldwide. The problem was identified during a pre-procedure inspection of the product at a customer site.

The recommended patient weight ranges for the GVL® Stat 1 and 2 overlap between 1.8 - 3.8 kg. The population at greatest risk are those patients greater than 3.8 kg and up to 10kg and with a known or anticipated difficult airway. In this remote scenario, the unintended use of a GVL[®] 1 Stat may result in inadequate visualization of the patient airway during first intubation attempt, thus requiring a secondary attempt with the correct size of Stat or alternative intubation device.

How to Recognize that the Device May Fail:


There is no size identification marker directly on the GVL® Stat 1 or 2. A medical professional trained on GlideScope video intubation is familiar with the range of sizes by their visual appearance and is expected to have inspected their equipment prior to use. A medical professional should recognize the unexpected attachment of a GVL[®] 1 Stat, based upon the differences in the stat tip dimensions of a GVL[®] 1. The most prominent feature difference between the two Stat sizes (1 and 2) is a 13 mm difference in stat tip length.

The stat tip length for the GVL[®] 1 Stat is 15 mm and the stat tip length for GVL[®] 2 is 28 mm. The photograph below illustrates the mislabeled product.



Verathon will replace all affected GlideScope GVL[®] size 2 Stats that remain in your facility's inventory with new products that have been screened to ensure correct sizing per the label. The lot number for your GlideScope GVL[®] 2 Stat is located in two places:

- 1. on the outer carton/packaging label for a box of ten (10) stats (left image below) and
- 2. on the immediate sterile packaging label for each individual GVL[®] size 2 Stat (**right image below**).
