



## URGENT FIELD SAFETY NOTICE

Dear Beckman Coulter Customer,

Beckman Coulter is initiating a field action for the AQUIOS CL Flow Cytometer relating to the Export feature for Tetra Combo testing. This letter contains important information that requires your immediate attention.

ISSUE:	Beckman Coulter has confirmed that the Export feature located in the Results area of the AQUIOS System software is not correctly exporting Tetra Combo CRD files.
IMPACT:	<ul> <li>The data and results on the acquisition system are not impacted.</li> <li>Upon import of the exported file to another AQUIOS workstation, two individual files will be generated in the results tab rather than one combo file.</li> <li>The possibility for erroneous results will occur under the following sequence of events:         <ul> <li>using the export button to export a Tetra Combo CRD file from the acquisition system and</li> <li>importing the data into a different system with a highly populated database and</li> <li>moving a region in any of the plots will generate erroneous results upon recalculation of the data.</li> </ul> </li> </ul>
ACTION:	<ul> <li>Do not use the Export button export Tetra Combo CRD files.</li> <li>To export the Tetra Combo CRD files from the system, use the export icon, which exports the run displayed on the screen.</li> <li>Refer to the AQUIOS Instructions for use, PN B21896 AD, Chapter 6- Data Review for further instructions.</li> </ul>
RESOLUTION:	Beckman Coulter has identified the cause to be a software anomaly to be addressed with a subsequent software release.

The national competent authority has been informed of this field safety corrective action.
