#### Dear Customer:

Lodox Systems (Pty) Ltd have initiated a field safety corrective action on Statscan VEO and Statscan VE1 model devices. The field safety corrective action addresses a possible malfunction that could potentially occur if the device is used beyond the expected useful life of the device (10 years).

#### Description of the problem:

With extensive and prolonged use of a device beyond the expected useful life of 10 years, shaving of the cable loom within the C-arm housing due to movement of the C-arm, can damage the cable loom. The damage could become extensive and then lead to a malfunction.

#### Potential risk:

A damaged cable loom can cause a malfunction which could lead to an incident in which either the user, patient or body (forensics) could be injured or damaged.

#### Advice on action to be taken by the user:

No action required from the user to address the field safety corrective action. It is required of each user to return the completed FSN notice form below to the nominated representative by 5 November 2017.

#### Field Safety Corrective action to be taken by service technicians:

Lodox Systems (Pty) Ltd will contact and plan a preventative service on each of the affected devices. Priority will be given to devices in-use for more than 10 years.

This field safety corrective action shall be addressed at all effected sites by 31 March 2018.



The field safety corrective action includes the following:

- 1. Add a label that will serve as a reminder for production, installation and service technicians that indicate the correct height of the cable loom to prevent possible damage.
  - a. If the cable loom is found to be below the required levels, the service technician shall adjust the cable loom accordingly.
- 2. Mount the cover securing screw (button head) from the top of the bracket below the cable loom to prevent sharp edges protruding on the inside of the C-arm.
- 3. Add a rubber strip over the steel bracket to prevent cable loom damage due to movement.

#### Transmission of this Field Safety Notice:

This notice needs to be passed on to all relevant persons who need to be aware, within your organization, of the field safety corrective action which will include a service from a qualified service technician.
