Description of the problem:

DiaSorin has confirmed that the LIAISON® 1-84 PTH Assay (REF 310630) lot numbers 134909, 134909A and 134909B, may produce falsely elevated patient results. The affected lots were performing as expected upon release. The performance of the assay has changed over time and customers may not have experienced any shift in patient results. The probability of temporary adverse health consequences is remote.

DiaSorin continues to investigate this problem, which is believed to be isolated to a specific lot of raw material. No other lots of the LIAISON® 1-84 PTH Assay have used this lot of raw material or have exhibited this problem.

Advise on action to be taken by the user:

Recommended actions:

- Stop using the LIAISON® 1-84 PTH Assay (REF 310630) lot numbers 134909, 134909A, 134909B, and destroy any remaining inventory. A new lot is available.
- No recommendation with respect to review and follow up of patient results is provided due
 to the low risk to patient. Laboratories should follow their own procedures and policies for
 the review and evaluation of previous results.
