To whom it may concern,

This letter is to notify you that, in the interest of pending regulatory matters within the European Union medical device market, effective today the following Retinal Membrane Removal Instruments will no longer be available on the European market.

Under the European Union Medical Device Regulation, some classes of medical devices (such as the DEX[™] Forceps, DEX[™] Scissors, DEX[™] TIPS, Drip Droppers[™], Backflush Handpieces, and Disposable Cannulas) require a Notified Body to be involved in the conformity assessment and CE marking process. Such Notified Bodies also undertake routine audits of medical device manufacturers.

Katalyst Surgical has recently undergone a routine external audit by our EU Notified Body, The National Standards Authority of Ireland (NSAI). It was determined that a change made to the devices should have been reviewed by NSAI prior to the devices being placed on the market. Following that audit, NSAI has requested for us to discontinue the distribution of these products until the change can be approved.

As part of the effort to identify product already placed on the market, we request a list of all Retinal Membrane Removal Instruments product currently on your shelf with the following information:
