This is to inform you that Gentherm Medical, LLC (formerly Cincinnati Sub-Zero) is conducting a voluntary field correction involving:

UV Treo™ Advanced Temperature Management System is indicated for use to raise, lower or maintain the temperature of water flowing through a heat exchanger during cardiopulmonary bypass procedures. It may also be used with a hyper/hypothermia blanket.

Gentherm Medical, LLC ("Gentherm") has identified that the UV Treo is causing interference displayed on ECG (also referred to as EKG) monitors when UV Treo and an ECG monitor are electrically connected to a patient at the same time. Possible risk to patient includes loss of appropriate therapy, indeterminate injury or life-threatening situations.
