

## **URGENT FIELD SAFETY NOTICE**

Recall Number: R21-006 05 November 2021

Dear Recipient,

It has come to Acumed's attention that two batches of T15 Stick Fit Hexalobe Drivers have features out of specification. The grooves appear rough, and the lobes are off center and larger than acceptable (as pictured in Image 1). This results in the tip of the driver not fitting into the Hexalobe feature of a screw. This situation occurred due to an internal manufacturing error.




Image 1. Example of recalled batches pictured on the right

To date, there have been no reported incidents of injury associated with this product. A Field Safety Corrective Action (FSCA) to withdraw this product from the field has been issued for the batches listed in the table below. The appropriate CAs have been informed of the FSCA.
